He declares that he has handed over a production package with the following own works to "Montez": 30 (thirty) original two-dimensional non-reproducible works, signed and / or authenticated, maximum size 10x10 cm that can be hung on a nail. By attaching a (single) photo for all works and a copy of the valid document and the tax code to the Independent Producer declares on its own responsibility:

- 1) that the personal information reported above is true and correct in every respect;
- 2) that the artist coefficient and the sale price of the works derive from the be \*\* pART algorithm, which can change in any case by increasing or decreasing, approved ladies will be accepted in any case;
- 3) that I do not need immediate and I do not urgently need to sell the works described;
- 4) that there is no recourse or mortgage on these works, nor that they are of illegal origin;
- 5) that the state of the work described above and its conditions comply with what is indicated;
- 6) that they are absolutely safe and comply with all existing safety standards;
- 7) to exclusively grant "Montez" the sales account mandate for all his two-dimensional works produced or which will be produced in the future, with a size of 10x10 cm or less;

8) to take legal responsibility for the content provided and to authorize the digitalization and dissemination of the images and information relating to the Independent Producer and the works on each channel that "Montez" deems appropriate.

With this document, the Independent Producer also assumes all responsibility deriving from incorrect declarations as well as the use of the works described above, their marketing and/or anything else that can be correlated, exempting "Montez" from any controversy and liability. "Montez" for his part:

9) will recognize to the Independent Producer an artist coefficient and a dynamic selling price which may vary over time. 50% of the sale price of the Works described above will be awarded to the Independent Producer, after the sale has taken place and as compensation for all its services. In the event that the artist is regularly represented by one of the be \*\* pART curators, then the percentages will be recognized in the measure of 45% to acMontez, 45% to the Independent Producer and 10% to the Curator, after the sale has taken place and as compensation for all services performed.

10) will make a withholding tax of 20% on the amount paid, which is payable by the 16th of the month following the payment;

11) reserves the right to withdraw from the contract signed by returning the goods to the Independent Manufacturer at any time if it deems it appropriate;

12) also declares that it is not a taxable person since the transfer of the business is not carried out by a company. Therefore, the transaction in question is not included in transactions subject to VAT pursuant to art. 1 D. P. R. of 26.10.72 n. 633. "Montez" further states that the Creator's personal data:

13) are collected to fulfill the obligations related to the company's economic activity, in particular for legal, administrative, accounting and tax obligations; 1

14) are processed in a lawful, correct way and to guarantee maximum confidentiality and security. They are also recorded and archived in computer and / or paper archives;

15) can be communicated and / or disseminated, if necessary and only in the cases provided for by law, to: • External persons who, on behalf of our company, perform certain tasks for accounting and the preparation of annual financial statements and to comply with tax regulations; • banks for the management of collections and payments resulting from normal commercial activities and / or from the execution of existing contracts.
